10.00 – 11.00 am PT	<p>Session two: <b>Practical tools: What does working with IWCA mean in practice?</b></p> <p>In this session we will deep dive into tools and GHG calculation processes developed by IWCA and others, to help you reduce your climate impacts. Key areas of focus will include reviewing IWCA Member GHG Emissions Hotspots to understand what actions wineries can take now to reduce their footprint, and which will require longer term, collective industry action.</p> <p>We will also debut the US based IWCA GHG Emissions Calculator, a DIY Excel tool that conforms to the World Resource Institute's GHG Protocol and the ISO 14064 process, which are widely regarded as the global gold standard in emissions reporting.
